TERMS AND CONDITIONS

2. All purchases by Applicant of goods and/or services from NSC will be made in accordance with the terms and conditions of this Application and any invoices and/or other document evidencing Applicant's obligations to NSC, all of which are incorporated herein by this reference.
3. The entire outstanding balance due to NSC on all invoices shall become due in full immediately upon default in the payment of any invoice. Applicant agrees to pay all costs of collection incurred by NSC, including attorney's fees and expenses, should default in payment or any other obligation of applicant to NSC occur.
4. If this application is not fully approved or if any other adverse action is taken with respect to Applicant's credit with NSC, Applicant has the right to request within 60 days of NSC's notification of such adverse action, which statement will be provided within 30 days of said request. To obtain the statement of specific reasons, please contact our credit department. Applicant understands and agrees to be bound by the above terms and all invoices and other documents furnished by NSC from time to time, all of which are incorporated herein by reference, and to advise NSC of any material change in the information provided herein, including but not limited to, change of ownership, address or telephone number.
